# **Conditions of Payment**

Full payment must be received within 30 days from the invoiced date for the application to be considered.

All payment must be made in Australian Dollars.

# **Payment Methods**

The Australian Earthing Institute will invoice the successful company upon receipt and processing of the sponsorship prospectus application.

The following payment options will be permitted with all details and terms and conditions outlined on the invoice: Credit Card via our secure payment portal, or EFT/Bank Transfer.

50% of the contracted amount will be retained for cancellation requests between 12 to 3 months prior to the event.

100% of the contracted amount will be retained for cancellation requests received 3 months prior to the event.
